## CAMP POLICIES

**Payment Policy:** You must pre-pay the full amount for each session in order to hold your child's place. If your child is not able to attend the session that he/she is signed up for and you contact the appropriate camp director **2 DAYS** before the session, you will receive your money back minus the cancellation processing fee. Any later notice than the 2 days before the session you will not receive any refund. ***All cancellations must be in writing via e-mail or in person.***

**Weather Policy:** In the case of inclement weather, we will make every attempt to keep the campers busy indoors. However, persistent rain may result in a cancelled day which can be made up in a future session where there is available space (please call for availability).

**Dropoff & Pickup:** Please do not drop off your child(ren) early or pick up late because we are not setup for childcare before or after camp hours. We ask that you **DO NOT** drop off your children more than 15 minutes before start time and that you pick them up **AT** the camp end time. Parents not adhering to this policy will be charged a fee to be assessed at the time of non-compliance.

Releasor acknowledges and agrees that Releasee will suffer irreparable harm in the event Releasor breaches the foresaid covenant and agreement not to sue, and that monetary damages would be insufficient to remedy the breach and, accordingly, that this covenant not to sue shall be specifically enforceable by the Releasor by injunction against Releasee.
