The Women's Amateur Championship is open to amateur female golfers who have up-to-date USGA Handicap Index not exceeding 8.0 under the USGA Handicap System.

The Senior Women's Amateur Championship is open to amateur female golfers who have reached their 50th birthday by January 21, 2019 and have up-to-date USGA Handicap Index not exceeding 9.0 under the USGA Handicap System.

If either event is over-subscribed, preference will be given to the lowest handicap entries. Players whose entries have not been accepted will be contacted and asked if they would like to be placed on a wait-list. Entries are subject to rejection at any time (including during the Championships) by the Tournament Committee.

Entry Fee: \$325.00 – *Includes tournament only cart fees for player, practice facility, players' dinner, players' buffet luncheon daily, on-course snacks, continental breakfast daily and players gifts.*

Field Limit: Amateur & Senior (total field not to exceed 80 players)

Championship Flight of 16, First Flight of 16, Second Flight of 8 (Defeated players from each Flight on Tuesday may play an optional single round of stroke play consolation on Wednesday). **Note: If an event is over-subscribed, the Committee reserves the right to add flight(s). If an event is under-subscribed, the Committee reserves the right to accept entries after closing and change flight sizes to limit "byes". Flights with less than 6 players will play a 36-hole stroke play competition.**

Practice: A single practice round will be extended to accepted players only. All players must take a golf cart for practice rounds (cart fee \$31.80 per person riding). Players will be limited to a single practice round.

Local players (living within 50 miles) must play before Sunday, January 20. Players may call the Golf Shop (954-449-4420) after their entry acceptance has been received for times prior to Saturday, January 19. Times for Saturday, January 19 will be available beginning on Monday, January 14.

Out of Town Players (living outside 50 miles) may play on or before Sunday, January 20. Players may call the Golf Shop after their entry acceptance has been received for times prior to Saturday, January 19. Times for Saturday, January 19 and Sunday, January 20 will be available beginning on Monday, January 14.

Cart/Caddie A player may provide her own caddie or carry her own bag. Pull carts are permitted and Club has a few rental carts. **AUTOMOTIVE TRANSPORTATION is available FOR PLAYERS ONLY** during any stage of the Championship. Players will not be guaranteed a single cart until all players will have access to a single cart. CADDIES MUST WALK AT ALL TIMES during a stipulated round. A player may request a golf cart for her caddie due to a permanent disability (as defined under the Americans with Disabilities Act). Requests due to temporary injuries or impairments will not be granted. The player for whom the caddie is working must submit a written request to the Doherty Tournament Committee with player's entry. Procedures, requirements and forms will be obtained from the Committee and follow guidelines set by the USGA. www.usga.org/champs/ada.
